

# CEA President Johnson to share ideas in Washington, D.C.

When U.S. education officials meet next month with educational leaders from throughout the country, CEA will have a seat at the table.

Supt. Gene Harris
have been invited
to attend a meeting with U.S. Secretary of
Education Arne
Duncan in Washington, D.C. on Dec. 7.
They are among only nine



Johnson and Harris were invited because of our collaborative Association-Administration efforts. CEA has accomplished a great deal, including the PAR program and Gainsharing, and we look forward to sharing our processes and results with government officials and with our peers nationally.

Duncan's major effort has been on gathering best practices surrounding teacher training, management, the use of student data and sharing them nationally. He also believes strongly that school district and teacher leaders hold the keys. In a recent speech at the U.S. Chamber of Commerce's Education and Workforce Summit, Duncan said, "We need to change the frame around reform and recognize that the crisis in education goes far beyond labor issues. Where we see academic failure, we need to get to the core of what is really preventing student achievement. When companies struggle, we don't start by firing the workers. We change leadership—and in many schools and districts—we have to look at leadership."

# Educator license renewal update

All educators who hold an 8-year certificate or 5-year license that will expire June 30, 2010, should already have re-

ceived a renewal packet from the CCS Human Resources Office. The deadline for renewal is Monday, Feb. 1, 2010, for educators who do not have a continuing contract with the district. Educators with continuing contracts have until June 21, 2010, to submit their renewal appli-

Monday February 2010 cations. If you have not received your renewal packet or have questions about a continuing contract, call Cheryl Creamer (Teacher Licensure) at 365-5658.

Because the Ohio Department of Education has completed all 2009 renewals ahead of schedule, they are renewing 2010 licenses early. Educators transitioning from an 8-year to a 5-year license or renewing a 5-year license may turn in their applications to the LPDC Office at Northgate Center now. However, on Jan. 1, 2010, ODE will release updated applications that reflect new standards surrounding the FBI/BCI background checks. This could save you some money if you have completed the fingerprinting procedures over the past two or three years. The language surrounding this new policy has not yet been completed, so specifics are not available at this time. You may wish to wait until after Jan. 1 to complete and turn in your application.

College credits are not recorded in PD Planner (only CEUs), so when using semester or quarter hours for renewal, you must attach an original transcript to your application. Please have the transcript sent to your home. It is permissible to open and attach it to your application. The LPDC has access to every educator's CEUs in PD Planner, so you do not need to print out and send that information along with your application. #### The middle school turnaround

CEA has received numerous calls from members who want to know about "middle school turnaround" and what middle school principals did when they recently went out of town for professional development. The paragraphs below are designed to answer some of your inquiries.

CCS middle school principals have been identified by the Superintendent to participate in "The Turnaround Challenge" for middle schools. Middle schools around the country, including Columbus, are faced with similar challenges around student achievement. "The Turnaround Challenge" represents a documented, dynamic, dramatic and sustained change in the performance of specific organizations including schools.

Dr. Harris has challenged the middle school principals to become "Turnaround Specialists" for their schools and for their students.

This process began with 22 middle school principals taking an active part in a week long learning institute, "Partnership for Leaders in Education," sponsored by the Darden School of Business and the Curry School of Education located at the University of Virginia in Charlottesville. During the course of this intensive week, middle school principals engaged in facilitated and interactive workshops and discussions around topics such as the following:

- ➤ Expanding leadership capacity to build a guiding coalition at each school
- ➤ Developing and communicating a clear and com-

- pelling vision
- ➤ Developing instructional and operational strategies to support the vision
- ➤ Transforming learning that results in higher student engagement and performance
- ➤ Transforming schools into high performing learning communities

Each principal was challenged to implement a "Quick Win" for his or her building climate and/or culture. "Quick Wins" represent visible, dramatic and sustained changes in programmatic features of the school curriculum and/or school operations.

In addition to the "Quick Wins," middle school principals will meet with the Superintendent and members of the CCS Senior Leadership Team to continue the dialogue and conversation on turnaround strategies. The expectation is that school leadership teams will also have conversations on a regular basis in order to further refine the strategies that will be implemented at their respective schools.


All middle school teachers, support staff members and selected parent consultants are being interviewed by Community Research Partners in order to provide further insight into middle school challenges, areas of concern and opportunities for improvement and successes. These interviews and focus groups have already begun and will be concluded by the end of this month.

CEA and the administration will continue to update you on middle school reform as developments occur.
