Make it a Day of Service

"Life's most persistent and urgent question is: What are you doing for others?" Dr. Martin Luther King, Jr. once said this to his flock. On Jan. 17, Americans across the country will answer the question by coming together on MLK Day to serve their neighbors and communities.

The MLK Day of Service is a part of the President's national call-to-service initiative. Americans from all walks of life are asked t

to our most pressing national problems, to bridge social barriers and to move our nation closer to the "Beloved Community."

Visit MLKday.gov to find resources for organizations and individuals who wish to serve, including marketing materials, advice on working with the media, project examples and checklists, tool kits, posters, web banners, a photo library, an MLK Day fact sheet—and more—to inform and inspire your planning efforts.

Be sure to register at www.serve.gov/recruit.asp once you have a plan. Here are some of last year's projects:

- AmeriCorps members and volunteers completed necessary repairs, building wheelchair ramps and providing energy-efficient upgrades for elderly and disabled homeowners affected by Hurricanes Katrina, Rita, Gustav and Ike in New Iberia, La.
- ☼ Volunteer New Hampshire collected more than 3,000 pounds of non-perishable food and personal hygiene items during the statewide 2010 MLK Food Drive.
- ❖ Volunteers from 24 Enterprise Rent-A-Car branches collected and distributed books to students at afterschool programs and helped launch the Speak Out & Listen Up campaign. Nearly 7,000 people participated in service projects and reflected on the teachings of Dr. King.

What is IPay?

IPay is the paperless method of viewing your pay statement each pay day.

Why should IPay be considered and what benefits are available?

- 1. With an IPay statement, you can see your information on Tuesday before the Friday payday. If you have any questions or issues, contact CCS Payroll before payday for early resolution.
- 2. How many times have you tried to find an old pay statement and just couldn't locate it? With IPay you no longer have to attempt to locate your hard copy pay

- statement. Rather, simply retrieve your statement from the IPay website and, if necessary, print your pay statement(s).
- 3. Your pay statement history will remain on the IPay website for a period of three years (the current year and the prior two years).

You may enroll in IPay with any of your pay statements you receive beginning with the paydays Dec. 17, 2010, and continuing through Feb. 25, 2011. Please remember the sooner you enroll, the sooner your available history begins to build. If you were receiving payroll payments from Columbus City Schools from December 2009–February 2010, you will already have some history on the IPay website. Once you enroll, your pay statements will be available for viewing and printing.

Don't miss your opportunity to build your personal history of pay statements. Enroll during the above-noted paydays in order to take advantage of this benefit and help conserve resources.

W-2s are available online through IPay, and 2010 W-2s will be posted by Jan. 31, 2011. CCS Payroll will also mail paper copies by Jan. 31 as required.

Get more \$everance

Retiring soon? To be eligible for super severance pay, you must notify CCS of your retirement by Friday, Feb. 1.

The district needs to know early for hiring planning purposes. The advantage for you in meeting this early deadline is a larger amount of money for unused sick leave. Article 810 of the *CEA Master Agreement* defines how severance pay is granted.

While it remains true that you will receive pay for 50 percent of your personal leave days regardless of when you notify CCS, notifying the district by Feb. 1 means you receive more for your sick leave. The example below represents a retiring teacher with a yearly salary of \$86,001 (Master's at Step 30) with a daily rate of \$441.03 (per diem), 410 sick leave days and 30 personal leave days.

The difference is \$23,154.08. You can see the obvious advantage to notifying the district by Feb. 1.

To assure consistent implementation throughout the district, it is very important that everyone (Senior FRs, principals and administrators) attend this training.

- Tuesday, Feb. 8: Regions II, III and IV High Schools, 7–12 Schools and Career Centers, 8–10 a.m./Northgate, Rm. G; Regions II, III and IV Elementary and Middle Schools, 1–3 p.m./Northgate, Rm. G
- Thursday, Feb. 10: Regions I and V High Schools, 7-12 Schools & Career Centers and District Programs/ Offices, 8–10 a.m./Northgate, Rm. D; Regions I and V Elementary and Middle Schools, 1–3 p.m./Northgate, Rm. D

Applications are being accepted for 2011 summer/fall graduate field courses and a master's program in international conservation studies in 12 countries throughout Africa, Asia, Australia and the Americas. New in 2011 are courses in Australia and Guyana.

Created in 2004 by Miami University's Project Dragonfly and the Cincinnati Zoo & Botanical Garden, Earth Expeditions graduate courses and now the Global Field Program (GFP) master's degree bring together graduate students, scientists, educators and community leaders at critical conserva-

tion field sites worldwide. In addition to Australia and Guyana, sites for 2011 include the Amazon, Baja, Belize, Borneo, Costa Rica, Kenya, Mongolia, Namibia, Thailand and Trinidad.

Tuition for seven graduate credits and all basic in-country expenses are covered in the \$1,250 course costs. Accepted students are responsible for airfare.

Earth Expeditions and the GFP, which can be completed part-time from anywhere in the United States or abroad, are open to educators and other professionals from all disciplines and settings, regardless of grade level or academic focus.
